- Ban on Noncompete Agreements (7/1/23)

### BENEFITS OF LEGISLATIVE VISITS

- Health care providers are facing rising health care costs, increasing bureaucracy, and administrative burdens which all impact delivery of care and patient access/experience—it is critical that legislators are made aware of these issues.
- Legislative visits educate policy makers and provide advocacy opportunities for ASCs.
- Visits allow relationship development which is helpful when facing future challenges on legislative issues.
- Increases visibility for ASCs and clinics.
- Pressures on healthcare providers, particularly independent practices has increased significantly every year it is important that legislators know their local independent practices and the impact legislation has on those practices.
